## **6) Offers of places**

Offers are made depending on the availability of places and our ability to make reasonable adjustments to meet the needs of learners.

Places are confirmed by email. Waiting lists will be maintained if a class is full.

All parents / carers will be required to complete and sign the Terms & Conditions form as part of the Admissions process.

Payment should be made in full in advance of the start of term on receipt of the invoice.

In the event of withdrawal, half a terms notice, in writing, is required of such intention or the equivalent of one term's fees will be payable in lieu.

Italia Conti reserves the right to alter or withdraw offers at any point.

## **7) Unsuccessful applicants**

Where we are unable to offer a place, applicants are informed via email no more than 2 weeks after their application has been received.
